\*Report from Dean on Conference in Menominee for National Drug and Alcohol Abuse. CPC had a booth which was sponsored by New York. Seven exhibitors were there and all but the AA booth were private drug and alcohol treatment centers. Theme was the opioid crisis. There were misconceptions about AA, with questions such as "How much are you paid to do this?" "How much does AA cost?". Private programs gave credit to AA for being the first credible program of its kind. No one can replicate the one on one benefit of an alcoholic talking to another alcoholic, and the sense of community that brings. Great experience and there were local AA's in attendance.

\* An idea for a picnic was presented and the idea was well received. Instead of holding a separate event, it was voted and approved that the District donate \$50 to the Newberry Campout, if the donation is wanted. Many at the meeting are planning to attend and take it back to their groups.
